Read: Letter No. DYSP/TRF/NORTH/1883/2026 dated 25-08-2026 from the Dy. Supdt. of Police, Traffic (N), Altinho, Panaji-Goa.

Whereas, the Deputy Superintendent of Police, Traffic (North), Altinho, Panaji-Goa, has informed that Hon'ble Defence Minister of India, will be visiting Goa from 26-08-2026 to 27-08-2026 and will be travelling from Mopa Airport to Hutatma Smruti Smarak at Patradevi to Hotel Taj Horizon, Panaji to INS Hansa.

And whereas, the Dy. Superintendent of Police, Traffic (North), Altinho, Panaji has proposed/recommended for temporary restriction on movement of Heavy Commercial Vehicles on 26-08-2026 on the stretch of NH-66 in order to ensure obstructive free passage to the VIP and for orderly parking of vehicles.

Now therefore, in exercise of the powers conferred on me under Sections 115, 116 & 117 of the Motor Vehicles Act, 1988, and as proposed/recommended by the Dy. Superintendent of Police Traffic (North), Altinho, Panaji, I, Ankit Yadav, IAS, District Magistrate, North Goa, do hereby notify temporary restriction on movement of Heavy Commercial Vehicles/Parking on 26-08-2026 at below mentioned places.

1. On 26-08-2026 from 16.00 hrs. to 20.00 hrs. there shall be restriction on movement of Heavy Commercial Vehicles on the stretch of NH-66 from Colvale to Border Check Post, Patradevi.
2. During the movement of VIP Carcade all the vehicles on NH-66 shall be diverted via alternate roads or halted at various locations.

The Dy. Superintendent of Police (Traffic), Altinho, Panaji is directed to publish this Notification through the Director of Information and Publicity in press/media/social media regarding the movement of Heavy Commercial Vehicles and to make necessary arrangements to erect the signboards at the required places for the information of the motorists and other road users.

This supersedes earlier Notification No. 23/6/2026/MAG/North/2882 dated 21-08-2026 and Corrigendum No. 23/6/2026/MAG/North/2896 dated 24-08-2026.
