Read:- Notification No. 01/2026–Central Tax dated 21-04-2026 issued by Central Board of Indirect Taxes and Customs, published in the Gazette of India, Extraordinary, Part II, Section 3, sub-section (i) dated 21-04-2026.

In exercise of the powers conferred by sub-section (6) of Section 39 of the Goa Goods and Services Tax Act, 2017 (Goa Act 4 of 2017), the Commissioner, on the recommendations of the GST Council, hereby extends the due date for furnishing the return in FORM GSTR-3B for the month of March, 2026 till the twenty-first day of April, 2026, for the registered persons who are required to furnish return under sub-section (1) of Section 39 read with Clause (i) of sub-rule (1) of Rule 61 of the Goa Goods and Services Tax Rules, 2017.

2. This notification shall be deemed to have come into force with effect from 20th day of April, 2026.
