The Local Complaints Committee shall perform the following functions in Kushavati District, Goa as per the provisions outlined in the Sexual Harassment of Woman at Workplace (Prevention, Prohibition & Redressal) Act, 2013.

(1) Prevention of Sexual Harassment:

To create awareness about sexual harassment and its prevention.

To develop a policy for the prevention of sexual harassment.

To organize workshops and training programs for employees.

(2) Redressal of Complaints:

To receive and inquire into complaints of sexual harassment.

To conduct investigations and take appropriate action.

To provide counseling and support to the complainant and the respondent.

To render all reasonable assistance to the aggrieved woman.

(3) Monitoring and Review:

To monitor the implementation of the Act and Policies thereof.

To review the functioning of the Local Complaints Committee periodically.

(B) Jurisdiction of the Local Complaint Committee:

The Local Complaints Committee shall be guided by the provision and or guidelines issued by the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 and the rules made thereunder in the South Goa District.

(C) Tenure of the Local Complaint Committee:

The Chairperson and every member of the Local Complaints Committee shall hold office for such period, not exceeding three years, from the date of their appointment.

(D) Terms & Conditions governing the Local Complaint Committee:

The role of the Local Complaint Committee shall strictly be in accordance to the various provisions of the said Act.

(E) Secretarial Assistance and Fees/Allowances, etc.:

The Directorate of Women & Child Development shall provide all the Secretarial assistance, logistics, TA/DA, fees, allowances, honorarium etc. to the Committee/Members as per their entitlements for smooth and effective discharge of its functioning.

(F) Handling of complaints by the Local Complaint Committee:

The committee is empowered to receive and inquire into complaints of sexual harassment as defined under Section 2(n) of the Act and in terms of the chapter IV & V of the Act. The Chairperson is authorized to co-opt any other expert/individual/Member of Public etc., as invitee member to assist the committee.

All inquiries and proceedings conducted by the committee shall be in accordance with the principles of natural justice and the procedure prescribed under the Act.

The committee shall submit its reports to the District Officer and concerned authority within the prescribed timelines, as stated in the Act.

(H) Appointment of the Nodal Officers:
