#### The Goa Appropriation (No. 3) Act, 2026

(Goa Act 14 of 2026)

[27-03-2026]

AN

ACT

*to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Goa for the services and purposes of the financial year 2026-2027.*

BE it enacted by the Legislative Assembly of Goa in the Seventy-seventh Year of the Republic of India, as follows:—

1. *Short title.*— This Act may be called the Goa Appropriation (No. 3) Act, 2026.

2. *Issue of Rs. 30194,89,41,000/-, out of the Consolidated Fund of the State of Goa for the financial year 2026-2027.*— From and out of the Consolidated Fund of the State of Goa, there may be paid and applied sums not exceeding those specified in column (5) of the Schedule to this Act amounting in the

aggregate to the sums of thirty thousand one hundred ninety four crore eighty nine lakh forty one thousand rupees towards defraying the several charges which will come in the course of payment during the financial year 2026-2027 in respect of the services and for purposes specified in column (2) of the said Schedule.

3. *Appropriation.*— The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Goa under this Act, shall be appropriated for the services and purposes expressed in the Schedule to this Act in relation to the said financial year.

**The Goa (Mopa Airport Development Authority) (Amendment) Act, 2026**

(Goa Act 15 of 2026)

[27-03-2026]

AN

ACT

*further to amend the Goa (Mopa Airport Development Authority) Act, 2018 (Goa Act 10 of 2018).*

1. *Short title and commencement.*— (1) This Act may be called the Goa (Mopa Airport Development Authority) (Amendment) Act, 2026.

(2) It shall come into force at once.

2. *Amendment of Section 8.*— In the Goa (Mopa Airport Development Authority) Act, 2018 (Goa Act 10 of 2018), in Section 8, for sub-section (1B), the following sub-section shall be substituted, namely:—

“(1B) The Authority may appoint its staff either on contract, regular basis, or deputation, on such terms and conditions as it may specify, for its smooth functioning, the expenditure on which shall be met by the Authority from its own funds.”
