- 1) The roads approaching both the bridges at both ends shall be suitably barricaded.
- 2) As soon as the work is completed the material used for the barricading shall be removed immediately and the roads shall be thrown open for normal vehicular flow.

- 3) Sufficient traffic signages regarding closure of roads and directional boards shall be erected on both ends of the bridges for the information of the motorists.
  - 4) During the closure of New Mandovi Bridge, light traffic may be allowed on Old Mandovi Bridge (both ways), heavy traffic shall be diverted through 3rd Bridge (Atal Setu).
  - 5) During closure of Old Mandovi Bridge traffic shall be allowed on New Mandovi Bridge (both ways) and 3rd Bridge (Atal Setu).
  - 6) The PWD Officials/Contractor carrying out the said work shall deploy sufficient Traffic Marshals for guiding the motorists accordingly.
  - 7) The PWD shall adopt all security measures to ensure safety and security of workers.
  - 8) The PWD shall make contingency arrangements, especially engaging services of fire force and medical aid in case of emergency.
  - 9) The PWD shall obtain necessary NOC's as required from all concerned authority/dept. well in advance.
  - 10) Notice in all local dailies/press shall be given for the information of the motorists.
  - 11) In case movement of any VVIP/VIP or Ambulance the road shall be kept open for movement of carcade and emergency vehicles.
  - 12) The road shall be completed within the stipulated times.
  - 13) Under no circumstances both the Bridges should be closed simultaneously.
  - 14) Panaji and Porvorim Police Station shall be informed well in advance regarding the road closure.
