No. 22/235/92-RD

Whereas by Government Notification No. 22/235/92-RD dated 19-8-93 published on page — of Series II, No. 46 of the Official Gazette, dated 10-2-94 and in two newspapers (1) Gomantak dated 30-8-93 (2) Navhind Times dated 31-8-1993 it was notified under section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1894) (hereinafter referred to as "the said Act") that the land, specified in the Schedule appended to the said Notification was likely to be needed for the public purpose viz. Approach road of 8.0 m span culvert at Rassaim including Palonda stretch in V. P. Loutulim of Salcete Taluka.

And whereas, the Government of Goa (hereinafter referred to as "the Government") after considering the report made under sub-section (2) of section 5A of the said Act is satisfied that the land specified in the Schedule hereto is needed for the public purpose specified above (hereinafter referred to "the said land").

Now, therefore, the Government hereby declares under the provisions of section 6 of the said Act that the said land is required for the public purpose specified above.

- 2. The Government also hereby appoints under clause (c) of section 3 of the said Act, the Land Acquisition Officer P.W.D. (Cell), Altinho, Panaji, to perform the functions of a Collector for all proceedings hereinafter to be taken in respect of the said land, and directs him under section 7 of the said Act to take order for the acquisition of the said land.
- 3. A plan of the said land can be inspected at the office of the said Land Acquisition Officer, P.W.D. (Cell), Altinho-Panaji, till the award is made under section 11.
